Gift Aid Notes

HDFAS is a charity registered with the Charity Commission.

You can cancel this declaration at any time by notifying HDFAS.

You must pay an amount of tax that is at least equal to the total amount of income and/or capital gains tax that can be reclaimed for that tax year by all the charities and Community Amateur Sports Clubs (CASCs) to which you donate. Council tax and VAT do not count. Since charities and CASCs can reclaim gift aid at 25p for every £1 that you give, this means that your total income and/or capital gains tax must be more than a quarter of your charitable giving.

If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the total amount of tax that can be reclaimed by all the charities and CASCs to which you donate, you should notify HDFAS and cancel your declaration.

If you pay tax at a higher rate you can also claim back the difference between the standard and higher rates of tax in your Self Assessment tax return.

If a member's subscription is paid by a spouse or partner, tax can be reclaimed if that spouse or partner makes the gift aid declaration, but only if both are members of HDFAS. A declaration by a tax-paying spouse or partner who is not a member but pays the subscription of a non-tax paying member is not acceptable under HMRC rules.
